 Skyrunner plans to bring new service to 454 new locations with Fiber Optic Internet Service - up to 1000Mbps symmetrical. This is new service to 24.7% of unserved locations in Transylvania County. These areas are pockets of the county that have been bypassed by other terrestrial internet service providers due to the topography and other factors making them expensive to serve. These areas are typical of the problems serving the last mile in Transylvania County.

1. The identity of the applicant and its qualifications and experience with the deployment of broadband.  
 Skyrunner, Inc., is a North Carolina corporation headquartered in Asheville, NC. Founded in 1999 as NewEraComm by Don Davis, we were pioneers in the deployment of wireless network technologies, installing some of the first wireless Internet links in the Southeastern US. After reincorporating as Skyrunner, Inc. in 2004, the company quickly expanded in all directions from its core in Buncombe County. We now serve over 9,400 customers in 18 counties in western North Carolina and upstate South Carolina. We presently have 39 employees including field technicians, customer support staff, engineers, and management. Our annual gross income is over \$11 million, and we have been consistently profitable over the life of the organization.

The Skyrunner team's expertise in terrestrial fixed wireless networks is nationally recognized by our consulting customers and our industry working group WISPA. We have consulted with other ISPs all across the country on radio deployment, router management, and network design. Our wireless Internet customers consistently give us high ratings on performance, customer support, and dependability; our current Google customer rating is 4.6 stars out of 5. We believe the proof of our technical prowess is our low customer turnover and our frequent accolades in social media.

In addition to being wireless experts, Skyrunner is also an experienced fiber-optic network provider. We began our first fiber-to-the-premises (FTTP) deployment in 2015 to a 100 home development in East Asheville. Since then, we have installed both fiber optic and hybrid fiber/wireless networks over 40 WNC communities, Hot Springs NC, Cashiers NC, including a 435 home development in Yancey County and an 1800 resident retirement community in Asheville. The demand for Fiber to the Premise services has skyrocketed, with many communities currently on our coming soon list. We operate a full-time fiber optic cable construction crew supported by a range of in-house equipment including vibratory plows, directional drills, and bucket trucks. We are capable of quickly and efficiently building out both underground and aerial fiber optic cable plants.

2. Skyrunner has secured a partnership with Transylvania County municipal government for the purpose of delivering fiber to the premise broadband services for the locations submitted in this GREAT Grant application.

3. Engineering and construction services will be provided by internal Skyrunner staff some elements of construction may be performed by outside construction partners that will be selected via RFP process. Skyrunner has long-term working relationships with many utility construction companies across the country that will be included in the comparative RFP process.

All locations in the project area are eligible for GREAT Grant funding based on FCC Form 477 data, and locations were determined using the GREAT Grant Mapping Tool.

According to Appendix E of the GREAT Grant Guidance document, 1,837 locations in Transylvania County are unserved at speeds of 25/3. Skyrunner plans to bring new service to 454 new locations with Fiber Optic Internet Service - up to 1000Mbps symmetrical. This is new service to 24.7% of unserved locations in Transylvania County.

According to the Broadband Indices released by the North Carolina Department of Information Technology, 11.3% of Transylvania County residents do not have access to 25/3 service excluding cellular and satellite. Of these respondents, 69.2% indicated that the reason that they did not have internet is because it simply was not available. More than 12.6% of these respondents also indicated that they did not even have access to cellular service.

Skyrunner is proposing to deploy fiber to the home to rural census blocks in five contiguous areas of Transylvania County currently unserved by terrestrial 25/3 Mbps service: Balsam Grove/Hwy 215 area, Indian Creek, Macedonia Church Road area, Parker Creek area, and along Blue Ridge Road,

The area is unserved by terrestrial service >25/3 Mbps as documented by the FCC 477 report (Dec. 2020). There are also multiple survey points from the "NC Broadband Survey" documenting less than 25/3 Mbps service in this area. Some residents in this area have poor quality DSL, satellite, or fixed wireless service at significantly less than 25/3 Mbps. Aerial poles carry electricity and telephone service to the area. This new project is a natural extension of the current Skyrunner footprint.

These areas are pockets of the county that have been bypassed by other terrestrial internet service providers due to the topography and other factors making them expensive to serve. These areas are typical of the problems serving the last mile in Transylvania County.

At the meetings, a Skyrunner representative will explain where the new broadband service will be available, the timeline for deployment, and answer questions from community residents. We will encourage the attendees to share the news of the coming broadband services with their neighbors through phone trees, social media, and their own community gatherings.

Skyrunner will also run advertisements in the Transylvania Times and the Cross Roads Chronical announcing the service areas and providing information on
